To develop harmonized European standards for the EU Data Act through the commissioning of CEN and CENELEC, the topic of data / data spaces is now also becoming very concrete. It is therefore now important to help shape the European and international standardization activities to ensure mutual connectivity!

The situation is characterized by an extremely heterogeneous field at national, European and international level. In addition, industry and users have a functioning overall system in focus. The cornerstones that are currently being defined in many interdependent areas, from data, data spaces, DPP, cybersecurity, AI to QI digital, must ultimately harmonize.
